Structure, Governance and Management

The Parochial Church Council is a corporate body established by the Church of England. The PCC operates under the Parochial Church Council Powers Measure.

Objectives and Activities

St John's PCC has the responsibility of cooperating with the rector in promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. In addition to the church building and the churchyard, the PCC also has responsibility for the maintenance of two thirds of the graveyard on St Giles Hill.

Achievements and Performance

Church Attendance

The church has 48 parishioners on the Electoral Roll, 29 of whom live in the parish. Average attendance for a typical Sunday Parish Eucharist, the major service of the week, is about 40, this number rising significantly at the principal festivals.

Review of the Year

PCC Report

The PCC met six times this year. Each meeting was a joint meeting of the two PCCs, All Saints and St John's.

Much of the PCC's attention has been given to the Leading Your Church into Growth (LYCiG) programme which commenced early in the year, agreeing priorities for action from LyCiG meetings and working sub-groups.

We had some preliminary discussion about employing a parish administrator to ensure good governance within the benefice and free PCC members for new projects identified by LYCiG.

We considered how to take forward the proposal to combine the two parishes, an idea which was supported at the APCM in April. Cathy Roberts, secretary to the Diocesan Pastoral Committee attended the September meeting to inform us how this could be progressed.

Gordon Randall, stewardship advisor presented 'Giving for life', a new resource for parishes at the November meeting. This focuses on giving as an outworking of discipleship. The PCC agreed to do some work to support stewardship including producing a legacy policy.

Rector's Report

It has been a year of change and development for East Winchester. At the start, we had Sam on placement, who especially enriched our singing. From October we had Philip as Curate, again with a great singing voice. Philip is also committed to ministry at St. Cross and brings oversight from a business background. Other ministry has been enhanced Deb, who has taken the Bishop's Commission for Mission, and the priestly ordination of Christine our curate.

Nicola has also been key to our ministry and has led the growing afternoon tea which attracts children and parents from All Saints school. Nicola moved to Suffolk in early 2017. The main innovation was Messy Church run with the support of Winchester Vineyard Church. This grew from some young families joining in with our Easter Eve bbg on the previous year.

Earlier in the year, we ran the "Leading Your Church into Growth" course as we built upon our earlier Mission Action Plan with the support and oversight of Margaret. I also led an ordination retreat in Uganda building upon our parish's links with ordinands in that country. Quite a contrast to life in Winchester.

During the year I accepted a post in the Diocese of London. I move on after 9 year in East Winchester, and I feel blessed by my time here, and by the support of the wardens Mike and Simon, and David and Deb, and wider PCCs. I will leave with very fond memories.

Churchwardens' Report

One of the highlights of the year has been the celebration of the first eucharist by Christine as our now fully fledged curate. This was very well attended, and we welcomed one of our previous rectors, Robert Teare, who preached on this occasion.

As a variation in our services, the year saw also the development of the Church@lunch as a noneucharistic activity which has been well supported throughout the year.

As usual, the churchwardens would like to offer their thanks to all those who help in so many different ways to keep the church functioning as a worshipping community.

Planned Giving Report

The Planned Giving Scheme is remaining fairly constant. During 2016 there were 28 members, but recently we have had a member leave for another church. The remaining members contribute regularly, either by weekly green envelope or by standing order, or in some cases, by both.

As service collections and wall safe donations are now included in the tax repayment claim, these should help the end of financial year figure to be approximately £4000.

Fabric Report

Activity this year has been confined to minor repairs, updating some of the lighting fittings, and repairs to the east wall, identified as necessary during the last quinquennial inspection.

Friends of St John

2016 saw no change in the composition of the Friends apart from the acquisition of three new members. No requests were made by the PCC in the year for help from the Friends' funds, but events, subscriptions and donations added over £500 which will be useful in 2017.

Matt and Abbey Sturgeon brought the entertainment group to which they belong (Pocket Theatre) to the Church in April at the request of the Friends. They performed music and songs from great shows of the past, including the Nightmare song from Gilbert and Sullivan. The evening proved to be great fun and so popular that by public demand they were invited to repeat the performance in 2017.

The Friends' Compline service and Advent Tea took place on the second Sunday in Advent and was well supported.

2016 as been Paul's last full year with us. We are grateful to him for his strong support of the Friends. Like everyone else connected with the Church we will miss him.

Financial Review

Total income was £24118. Expenditure was £29304, giving an excess of expenditure over income of £5186.

We are keeping a total of £37312 in the Diocesan Loan funds.

Reserves Policy

Our general fund balance on 31/12/2016 was £40637

It is our policy to invest any fund surpluses with the Diocesan Loan Fund no 5110.
